PARTNERSHIPS

The League partnered with **Tulsa's Young Professionals** to present a new event, "Pub & Politics," which helped young Tulsans get to know candidates for elected positions at the city, state and national levels. The League was later nominated for a **TYPros "Boomtown Award"** in the Advocates category.

The League partnered with **OETA** and **Oklahoma State University** to present three televised debates—the only gubernatorial debate of the year, a State Superintendent debate and another for U.S. Senate candidates.

LWV of Metropolitan Tulsa and LWV of Oklahoma lent their support to **Demos** (a public policy organization), **ACLU of Oklahoma**, **Project Vote** and **Lawyers' Committee for Civil Rights Under Law** to bring the Department of Health and Human Services into compliance with the National Voters' Registration Act.

From our participation in the state-wide candidate forums, an opportunity arose to participate in a voter registration field experiment with **Oklahoma State University**, LWV Oklahoma and the local Leagues.




