Early in-person absentee voting will be available at the Tulsa County Election Board, 555 North Denver, from 8 a.m. to 6 p.m. on Friday, September 9 and Monday, September 12.

**Each candidate in the nine City of Tulsa council districts was sent a questionnaire and given an opportunity to respond.** The League neither edits material submitted nor changes spelling, punctuation or grammar. If word limits are exceeded, the extra words are deleted, indicated by an ellipsis.

This Voter Guide does not include candidates who drew no opponents from their respective parties. Those candidates will be on the Nov. 8 general election ballot. The League of Women Voters will publish a general election voter guide in October 2011 with responses from all candidates on the general election ballot who submitted answers to the League's questionnaire.

## New Voter Identification Requirements

Oklahoma's Voter ID law took effect July 1. All voters are now required to produce proof of identity before casting a ballot whether voting at a regular polling place or voting early at the County Election Board.

Acceptable identification includes documents issued by the federal, state or a tribal government that includes the voter's name, photograph, and an expiration date that is after the date of the election in which the voter is attempting to vote. Voters also may use a voter identification card or a temporary voter identification document issued by the County Election Board.

The following ID will be accepted:

- A valid driver's license with an expiration date later than the day of the election.
- A state identification card, which is not a driver's license, with an expiration date that is later than the day of the election; persons 65 or older are not required to have an expiration date on their state identification card.

**The LWV of Metropolitan Tulsa** is a nonpartisan organization that provides information about political issues and candidates for public office in order to promote greater citizen responsibility and participation in government. As a nonpartisan organization, the League neither supports nor opposes any political party or candidate. It publishes and distributes factual information for citizens to use when preparing to cast an informed vote. **Candidates are listed by District, then by party affiliation. All candidates are listed in alphabetical order by last name.**

## Voter Identification Requirements, *continued*

- A tribal government ID, with a photo and expiration date later than the date of the election.
- A military/uniformed services ID, with a photo and expiration date later than the date of the election.
- A United States passport with an expiration date later than the date of the election.
- A voter registration card or a temporary voter registration document –the only forms of ID without a photo that will be accepted. A voter registration card does not have an expiration date. However, the temporary voter ID does have an expiration date and that date must be after the election.

The law does not require checking the voter's address, only that the name on the ID is similar to the name in the precinct registry (for example the ID may say John Edward Doe and the precinct registry says John E. Doe).

## No ID? Vote a Provisional Ballot

**Don't have ID? Ask for a provisional ballot!** It will take a little more time to do the paperwork, but the Tulsa County Election Board says your vote will be counted if you fill out the affidavit correctly. Poll workers are not permitted to assist voters with the paper work, so be sure to take your time and read the instructions carefully. Be sure the name you put on the affidavit matches what is on the voter rolls. This is the most important step in voting your provisional ballot. If the name on the affidavit that accompanies the provisional ballot substantially conforms to the name on the voter rolls, that vote will be counted.
