



# Voter Guide

NOVEMBER 8<sup>TH</sup> GENERAL ELECTION

The League of Women Voters of Metropolitan Tulsa is a nonpartisan organization that provides information about political issues and candidates for public office in order to promote greater citizen responsibility and participation in government. As a nonpartisan organization, the League neither supports nor opposes any political party or candidate. It publishes and distributes factual information for citizens to use when preparing to cast an informed vote.

## General Election — Tuesday, November 8<sup>th</sup>, 7AM to 7PM

*The general election is open to all registered voters in the City of Tulsa. All candidates who won primary races for their respective party's candidacy, or who were the only candidate for their party for a particular office will be on the ballot. Voters may select any candidate who appears on the ballot. Candidates for seven of the nine city council seats and four city charter change proposals will be on the ballot.*

### NEW VOTER IDENTIFICATION REQUIREMENTS

**Oklahoma's Voter ID law took effect July 1. All voters are now required to produce proof of identity before casting a ballot whether voting at a regular polling place or voting early at the County Election Board.**

Acceptable identification includes documents issued by the federal, state or a tribal government that includes the voter's name, photograph, and an expiration date that is after the date of the election in which the voter is attempting to vote. Voters also may use a voter identification card or a temporary voter identification document issued by the County Election Board.

#### **The following ID will be accepted:**

- A valid driver's license with an expiration date later than the day of the election.
- A state identification card, which is not a driver's license, with an expiration date that is later than the day of the election; persons 65 or older are not required to have an expiration date on their state identification card.
- A tribal government ID, with a photo and expiration date later than the date of the election.
- A military/uniformed services ID, with a photo and expiration date later than the date of the election.
- A United States passport with an expiration date later than the date of the election.

A voter registration card or a temporary voter registration document – the only forms of ID without a photo that will be accepted. A voter registration card does not have an expiration date. However, the temporary voter ID does have an expiration date and that date must be after the election.

#### **Don't have ID? Ask for a provisional ballot!**

It will take time to do the paperwork, but the Tulsa County Election Board says your vote will be counted if the name on the affidavit that accompanies the provisional ballot substantially conforms to the name on the voter rolls. Be sure the name you put on the affidavit matches the name you used to register to vote.

#### **VOTE!**

*You can vote in person at your polling place for the precinct in which you live.:*

- The name of your polling place is on your voter identification card.
- The polls are open 7 a.m. - 7 p.m. on election day. If you are in line by 7 p.m., you will be able to vote.

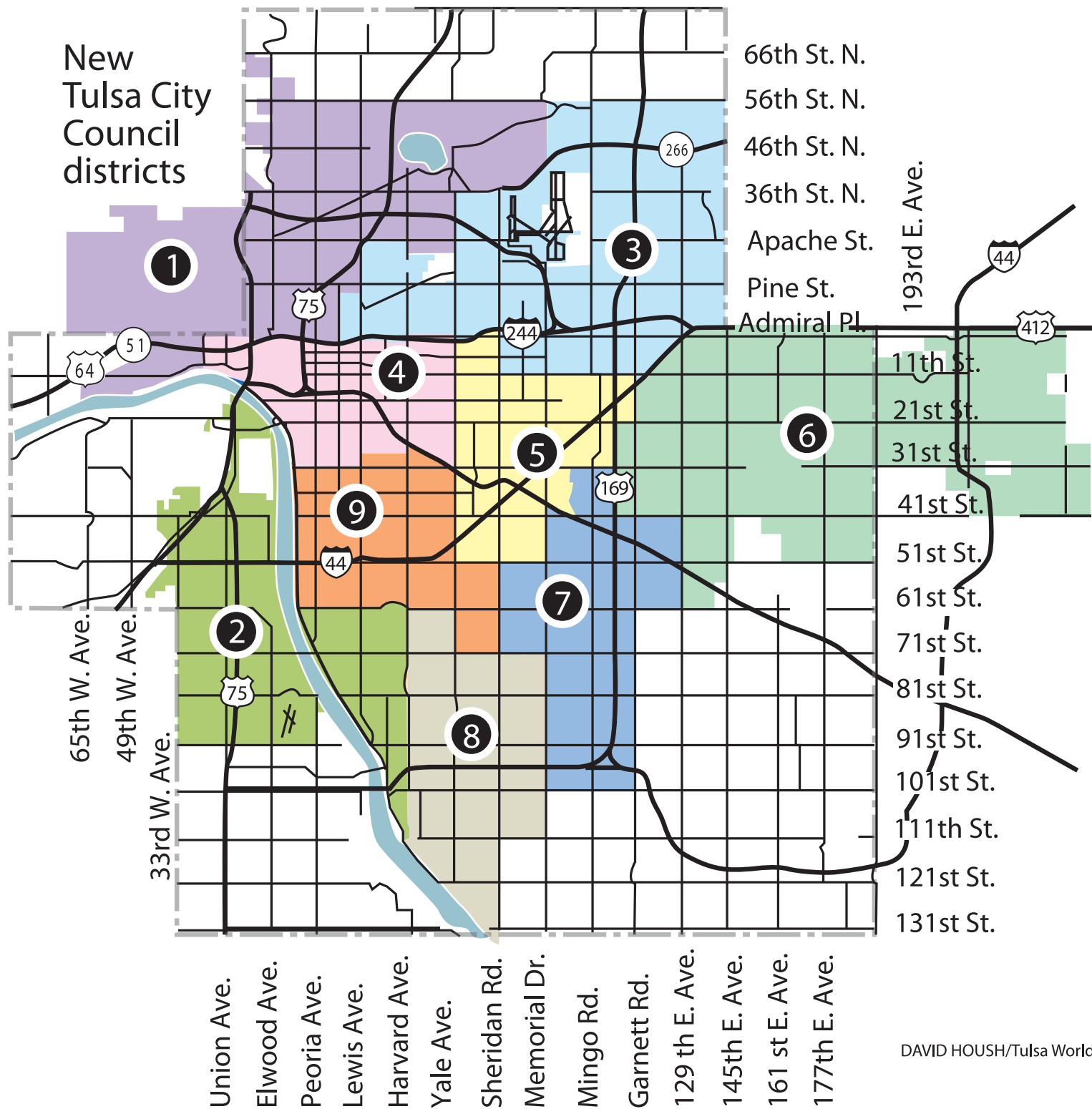
*You can also vote early or by absentee ballot:*

- Early in-person voting takes place from 8 a.m. to 6 p.m. on the Friday and Monday before municipal elections.
- An absentee ballot may be requested in person or by mail. The deadline for requesting an absentee ballot is the Wednesday before an election.

- **The League neither edits material submitted nor changes spelling, punctuation or grammar.** If word limits are exceeded, the extra words are deleted and this is indicated by ellipsis (...).
- **All candidates for municipal office are listed by district and in alphabetical order by last name in this guide.**
- **The following districts do not have candidates for City Councilor in the November general election:**
  - District 1 drew candidates from the Democratic Party only and Jack Henderson was elected as Councilor for District 1 in the primary election.
  - District 5 drew candidates from the Republican Party only and Karen Gilbert was elected Councilor for District 5 in the primary election.
- **Voters will go to the polls in all nine City of Tulsa districts:**
  - Voters in all districts, including Districts 1 and 5, will vote on November 8 on four ballot proposals for all voters in the City of Tulsa to decide.
  - A brief explanation of each of the four proposals, written by the League of Women Voters Voter Services Committee, is printed in this guide.
  - The League of Women Voters of Metropolitan Tulsa has taken a position on all of the ballot proposals and the positions are not printed as part of the guide, but may be found in the blue insert.

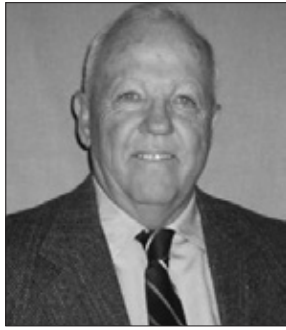
**3. What will you do to help improve relations between the executive and legislative branches of city government if elected?**

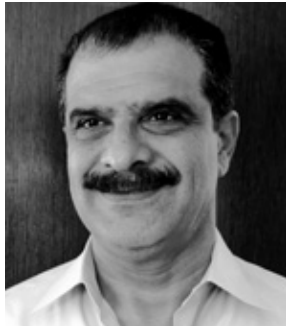
**3. What will you do to help improve relations between the executive and legislative branches of city government if elected?**

The key issue is a shared vision to work toward. **All voters in the City of Tulsa will vote on four charter change proposals.  
Below are the titles as they will appear on the ballot. This is not a typo; there are two No. 1s.  
The League—simplified explanations of those proposals are below.**

## **City Council-City Manager Form of Government, with the Mayor as Member of City Council Proposition No. 1**

This Resolution proposes to change how the City of Tulsa is managed by making the Mayor part of the City Council and vesting all executive and administrative decision-making in a City Manager. The City Manager would be appointed by the City Council to serve at its pleasure.

In addition to appointing a City Manager, the City Council would also be given the power to appoint and determine the duties of the City Attorney, City Auditor, City Clerk, City Treasurer and Municipal Judges. To remove the City Manager, City Attorney, City Auditor, City Clerk, City Treasurer, or a Municipal Judge from their appointment would require a super-majority, or 2/3 of the entire Council. The City Manager would replace the Mayor as a member of the Airport Authority, the Utility Board, and the Parks and Recreation Board.

The City Council would be comprised of a Mayor and nine (9) Councilors. The Mayor would be the titular representative of the City of Tulsa and would have no veto power over the legislative acts of the Council. The Mayor and the Councilors would run without declaring a political party preference (known as non-partisan elections). The term of office for the mayor, who would run at-large, and the nine (9) Councilors would be four (4) years. The terms of office for the Councilors are to be staggered. The staggering of terms will cause city elections to be held every two years. The Mayor and each City Councilor will be limited to serving no more than twelve (12) years on the Council.

### **Initiative Petition Proposition No. 1**

This Proposition would amend the Charter of the City of Tulsa to restructure the City Council making the Mayor a member of the Council and its Chairman. The Mayor would only cast a vote to break a tie. The Mayor would have veto power over any proposal adopted by the Council. Additionally, the Mayor would possess the power to create the agenda for the Council, call special sessions, request the purpose of any decision or action of the Council and send messages and recommendations to the Council.

Aside from the Mayor, the Council would be comprised of twelve (12) Councilors, three of whom would be elected from at-large districts encompassing the entire city. The remaining nine (9) Councilors would be elected by districts.

Absent the adoption of Initiative Petition Proposition No. 2 and No. 3 the date of City elections would remain the same, the term of office for the Mayor and Councilors would not change and there would continue to be partisan elections.

### **Initiative Petition Proposition No. 2**

Proposition No. 2 would change the timing of the City elections to coincide with election cycle established for state and federal elections. In order to accommodate such a change the term of office for various elected office holders for the City of Tulsa would be temporarily altered. After the temporary terms are completed the Mayor will be elected for a four (4) year term, the City Auditor and Councilors would be elected for a term of two (2) years.

### **Initiative Petition Proposition No. 3**

This proposed amendment to the City Charter would eliminate partisan elections for City officers.
